## Dear all

Thank you for your valuable support for the orphans in our care. It's been a challenging year with COVID-19 rife in the world. This time last year excitement abounded with the opening of Celebration High School. Our students were thrilled to be able to further their education, only to have their enthusiasm thwarted by the closure of CHS (due to the pandemic) in March of this year. Thankfully, in January 2021, we will reopen.

Sadly, some of the student's sponsors have experienced financial difficulty and can no longer continue their sponsorship. Currently we have no other funds to cover a student's fees if they lose their sponsor and money raised from our Christmas appeal this year will go to help any student whose sponsor has dropped out. We're prayerfully expecting to build up a pot of money that will enable them to remain at CHS.

If you can afford an additional gift this Christmas to meet this end it would be much appreciated. An education is key to helping a child in Kenya escape their poverty trap and have hope for a brighter future.

Alternatively, if you're able to support a student for their 4 years at Celebration High School, cost is £29 per month (£350 per year). This covers education, 2 x sets of uniform, shoes, text and writing books plus lunch.

All our students are either orphaned or disadvantaged and unable to progress without financial assistance and together we can continue to make a difference to these children's lives. Thank you so much again for your kindness and generosity. We really couldn't manage without you!
